4C Quarterly Cash Flow Report

Amplia Therapeutics Limited (ASX Code: ATX) has today released its Appendix 4C – Quarterly Cashflow report for the period ended 30 September 2018.

The cash balance as at 30 September 2018 was \$1,694,000. Cash outflows during the quarter totalled \$348,000.

The total estimated cash outflow for the quarter ending 31 December is \$645,000. This is a net amount after taking into account a Research & Development incentive payment of \$218,000 received in early October.

Spending on R&D is expected to increase significantly from a net \$84,000 last quarter to an estimated \$316,000 in this quarter. This increase reflects clinical trial enabling activities including scale up production of lead drug candidate AMP945 and commencement of a formal toxicology programme.

AMP945 is being positioned for an initial Phase I healthy volunteer study which is expected to provide the necessary safety, tolerability, pharmacokinetic, and pharmacodynamic data to support a Phase II programme in either cancer or fibrotic disease.
